 - A. Posted and maintained throughout the 2020 calendar year on the bulletin board at the Delaware Township Municipal Building;
 - B. Mailed or hand delivered to the three newspapers designated in Paragraph 2 of this resolution;
 - C. Filed with the Secretary of this Board, and;
 - D. Mailed to such persons as may be entitled thereto under the terms of the Act and this resolution.
- 4. Pursuant to Section 14 of this Act, the Secretary of this Board is thereby authorized and directed to mail such notice as may be required and authorized under the Act to any person requesting the same providing that person has complied with the following terms and conditions;
 - A. Any and all requests for notice under the Act shall be made in writing either by letter or by signing a Request List to be maintained in the Office of the Clerk, and
- B. Any person requesting such notice, other than the news media which is expressly excluded from payment of any fee hereunder shall pay to the Township of Delaware a fee of \$3.00, which said sum is hereby determined to be a reasonable sum, the amount of which is calculated solely to reimburse the Township for the costs incurred in providing the said notice; including but not limited to printing, photocopying costs, clerical time and postage.

- A. Resolution #2020-01 Non-Fair and Open Contracts for Township Professionals Mr. Textores read resolution to the board. This should be done annually by the board and published in the Hunterdon County Democrat. Jorge Berkowitz PhD moved to approve this resolution 2020-01 and Katie Hooven, PhD seconded the motion. Roll Call. All Voted Aye. No further discussion from board.
- **B.** Septic Waiver, B1, L8 911 County Road 579 Wayne Ingram, PE was present to address the board. This is a malfunctioning system to a3 bedroom dwelling with no expansion. Jorge Berkowitz, PhD asked about wells nearby and maintenance on the system. The board approved the waivers in the November 6, 2019 letter from the County Health Department. Michael Textores asked about the size of this property and if any vegetation will be removed. The board approved the waivers in the November 15, 2019 letter from the County Health Department. The board requested a copy of the GP24 approval. Michael Textores made the motion, Jorge Berkowitz, PhD seconded the motion. All Voted Aye.

- E. Septic Wavier, B13, L17 18 Pavilica Road Steve Parker, PE was present to address the board. This is a malfunctioning system to an existing 3 bedroom dwelling with no expansion. Jorge Berkowitz, PhD asked how deep is the well. The board approved the waivers in the December 19, 2019 letter from the County Health Department. The board was informed that this type of system will have additional requirements including a maintenance contract with a service provider for the life of the system, deed notice stating the type of system and installers shall be NEHA certified. Katie Hooven, PhD made the motion Jorge Berkowitz, PhD seconded the motion. All Voted Aye.
- **F.** Septic Waiver, B7, L13.01 Drip Dispersal and Hoot) 51 Stone Signpost Doug Fine, PE was present to address the board. This has a 4-bedroom dwelling with no expansion. The board approved the waivers in the December 12, 2019 letter from the County Health Department. The board was informed that this system (H-600A Hoot Aerobic) will have additional requirements including a maintenance contract with a service provider for the life of the system, deed notice stating the type of system and installers shall be NEHA certified. Jorge Berkowitz, PhD. made the motion, Michael Textores seconded the motion with conditions in the letter. All Voted Aye.
