 - A. Posted and maintained throughout the 2021 calendar year on the bulletin board at the Delaware Township Municipal Building;
 - B. Mailed or hand delivered to the three newspapers designated in Paragraph 2 of this resolution:
 - C. Filed with the Secretary of this Board, and;
 - D. Mailed to such persons as may be entitled thereto under the terms of the Act and this resolution.
- 4. Pursuant to Section 14 of this Act, the Secretary of this Board is thereby authorized and directed to mail such notice as may be required and authorized under the Act to any person requesting the same providing that person has complied with the following terms and conditions;
 - A. Any and all requests for notice under the Act shall be made in writing either by letter or by signing a Request List to be maintained in the Office of the Clerk, and
- B. Any person requesting such notice, other than the news media which is expressly excluded from payment of any fee hereunder shall pay to the Township of Delaware a fee of \$3.00, which said sum is hereby determined to be a reasonable sum, the amount of which is calculated solely to reimburse the Township for the costs incurred in providing the said notice; including but not limited to printing, photocopying costs, clerical time and postage.
