Mr. Herman motioned to approve the minutes from the August 12, 2019 Township Committee Meeting. Mrs. Lockwood seconded the motion.

TOWNSHIP COMMITTEE REPORTS

DPW

Mr. Kwasnik reported the roads scheduled for tar and chip will be completed within the week. Mr. Kwasnik stated Zentek Road drainage and paving is completed. Mr. Kwasnik stated Whiskey Lane and Boars Head Road drainage is completed and the paving will be started next.

Eagle Scout Project

Mr. Herman stated the Eagle Scout project at Dilts park has been going well. Mr. Herman reported the Eagle Scout has placed mile markers on the trail and created a map of the trail for the community. Mr. Herman stated the Eagle Scout has ordered a wooden sign for Dilt Park. Mr. Herman suggested that the Township possible cover the cost of the sign since the Eagle Scouts conduct the projects through donations.

Recreation

Mr. Herman thanked the Delaware Township Recreation Commission and all the volunteers for their hard work and dedication to a great firework display at Community Day.

Pipeline Sub-Committee

Mrs. Lockwood reported the Pipeline Sub-Committee will be meeting every week to review the PennEast documents that the Township received. Mrs. Lockwood stated the comment time is limited and will close once the PennEast application is approved.

Mrs. Lockwood stated the Pipeline Sub-Committee has drafted a letter to NJDEP regarding the compressor station expansion at the site on County Rt. 179 in West Amwell. Mrs. Lockwood explained the background of the expansion being done at the compressor station and that the expansion is to accommodate the PennEast pipeline. Mrs. Lockwood stated there appears to be no mention of the connection to the PennEast pipeline in the applications for expansion to NJDEP.

Mr. Herman motioned to approve and authorize Mayor Vocke to sign the letter as recommended by the Pipeline Sub-Committee. Mr. Kwasnik seconded the motion, and the members approved the motion by roll call vote.

MEETING OPEN TO THE PUBLIC FOR COMMENTS ON AGENDA ITEMS ONLY

Mr. Herman motioned to move item #17 on the agenda to the beginning of the meeting. Mrs. Lockwood seconded the motion, and the members approved the motion by an all in favor vote.

AUTHORIZATION OF A RECOMMENDATION BY PIPELINE SUB-COMMITTEE THAT A DRAFTED GROUNDWATER PROTECTION ORDINANCE BE REVIEWED BY DELAWARE TOWNSHIPS PLANNING BOARD AND THE DELAWARE TOWNSHIP BOARD OF HEALTH

Mr. Joe Wiley, Lambertville Road, stated members of the Pipeline Sub-Committee have concerns about the construction of the pipeline and the effect on the groundwater. Mr. Wiley stated there is no NJDEP permit that addresses the potential effect of the groundwater. Mr. Wiley stated there will be wells that can potentially be effected that are adjacent to the pipeline route. Mr. Wiley suggested the Township require baseline testing be required on any wells that could potentially be effected by the contamination and groundwater issues. Mr. Wiley stated PennEast should be required to submit a monitoring program and money should be placed in escrow with the Township, the same as a developer would be required to do. Mr. Wiley reviewed the information that was placed in the draft groundwater protection ordinance.

Ms. Kristen McCarthy, representing the Delaware Township Citizens Against the Pipeline (DTCAP), requested the Township consider obtaining experts such as a Geologist and/or Engineer.

Mrs. Lockwood stated the Pipeline Sub-Committee is reviewing areas that will need a professional and the Pipeline Sub-Committee will then put in a recommendation to the Township Committee.

Ms. McCarthy stated there is a possibility to hire Mark Gallagher and split the cost among a group of Municipalities affected by the Pipeline. Ms. McCarthy is concerned about the tight timeline. Mrs. McCarthy will review the scope of services and cost associated with hiring the professionals needed with the other municipalities.

Mrs. Lockwood stated the Pipeline Sub-Committee is reviewing the documents and will discuss the areas where an expert would be required. Mrs. Lockwood stated knowing areas the other municipalities have experts already reviewing would help the Pipeline Sub-Committee narrow down what experts would still be needed for certain areas, such as Horizontal Directional Drilling.

Ms. McCarthy suggested co-hosting with the Pipeline Sub-Committee a Community Pipeline meeting to update the community and property owners. Ms. McCarthy stated the meeting can be an open forum to discuss the experts that have been retained and give an update on the process, the progress and what the role is for the community.

Mr. Vocke will discuss with the school and see what the availability the school would have to schedule a community meeting.

Mr. Wiley stated the Citizens Against the Pipeline has published a flyer that is six pages and is a great summary about the pipeline. Mr. Wiley stated this flyer is posted at the Post Office.

Ms. McCarthy will request for volunteers to monitor the PennEast documents and offer residents additional Wednesday evening hours from 5:00 p.m. until 7:00 p.m., in addition to the daytime hours already in place, to review the PennEast documents at the Municipal Building.

Ms. McCarthy will check to see if the Citizen Against the Pipeline might be able to contribute toward the professional service of experts needed to review information. Ms. McCarthy will investigate the cost of experts and report back to the Township. Ms. McCarthy requested the Township reserve additional funds in the 2020 budget to help offset costs for the fight against the pipeline.

Ms. McCarthy stated that PennEast is claiming their mitigation plan is proprietary and not available to the public. Ms. McCarthy stated in the mitigation plan it shows what wetlands would be disturbed and what the plan is to put these habitats back to the undisturbed condition. Ms. McCarthy requested the Township Attorney OPRA this information from PennEast and/or send a letter to PennEast requesting that this information should not be considered proprietary.

Mrs. Lockwood suggested a letter be drafted from all Mayors, in the Municipalities affected by the PennEast Pipeline, as a joint effort to request the litigation plan and missing wetland information.

Mr. Herman motioned to authorize the recommendation from the Pipeline Sub-Committee to have the Delaware Township Planning Board and Delaware Township Board of Health review as soon as possible the draft Groundwater Protection Ordinance. Mr. Waltman seconded the motion, and the members approved the motion by an all in favor vote.

ORDINANCE 2019-16 – FIRST READING

DELAWARE TOWNSHIP ORDINANCE #2019-16

A CAPITAL ORDINANCE OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON, AND STATE OF NEW JERSEY TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM THE RESERVE FOR ROAD IMPROVEMENT FUND FOR THE PURCHASE OF ROAD IMPROVEMENTS IN THE AMOUNT OF \$35,000.00.

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon, and State of New Jersey as follows:

Section 1. Delaware Township has to make improvements including but not limited to a section of Lower Creek Road including repairs to the gabion walls in Delaware Township in order to maintain our road system. Delaware Township hereby authorizes an appropriation and expenditure for labor and materials to make improvements to Lower Creek Road, in an amount not to exceed \$35,000.00; and,

Section 2. Total amount to be expended from the reserve for road improvements shall not exceed \$35,000.00.

Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.

WHEREAS, failure to comply with the promulgation of the Local Finance Board of the State of New Jersey may subject the members of the Township Committee to the penalty provisions of R.S. 52:27BB-52 to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, and in addition shall forfeit his office."

MEETING OPEN TO THE PUBLIC

Ms. Klink updated the Township Committee that the Judge for the Cellco lawsuit upheld the Delaware Board of Adjustment decision. Ms. Klink stated the 45 days for a possible appeal from Cellco has expired.

Mr. McCumber stated the Community Day fireworks by the Delaware Township Recreation Commission were spectacular.

Mr. Gordon Darling wanted the following request on record:

Mr. Gordon Darling stated that nine years ago he paid for new sidewalks and curbing to be done in front of his prior residence on Rosemont Ringoes Road and he would like to request the Township reimburse him \$9,000.00 for the work that was done and paid for by Mr. Darling.

Mr. Herman asked Mr. Darling if the Delaware Township Planning Board required him to place the new sidewalks and curbing as part of the Planning Board application.

Mr. Darling stated that he had the sidewalks and curbing done on his own and that this was not a requirement.

Mr. Darling stated that he had a verbal agreement with a prior Township employee and that he would not like to mention any names. Mr. Darling stated that since the Township has now received a grant for sidewalks he would like to be reimbursed for the sidewalk and curbing work that he paid for when he owned the building.

Mr. Darling thanked the Township Committee and stated he wanted his request on public record.

FINAL COMMENTS OF THE TOWNSHIP COMMITTEE

Mr. Herman stated the sidewalk project is in the final steps, bids will be opened on September 10, 2019 and the easements should all be signed off on by Wednesday, September 11, 2019. Mr. Herman stated that the project should be finished by the end of October.
