REGULAR MEETING MINUTES

August 9, 2021 7:30pm

In Person

Mayor Waltman called the regular meeting of the Delaware Township Committee to order on August 9, 2021 at 7:30 PM. Mayor Waltman announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat, Trenton Times, Courier News and the Star Ledger, was posted on the bulletin board in the Municipal Building and filed with the Township Clerk on January 5, 2021.

PLEDGE OF ALLEGIANCE

Mayor Waltman led those in attendance in the pledge to the nation's flag.

ROLL CALL

Present: Mayor James Waltman, Deputy Mayor Joseph Vocke, Committee Members Daniel Kwasnik, Charles Herman and Susan Lockwood along with Township Clerk Maria Andrews, Deputy Township Clerk Tiffany Crivelli, and Township Attorney Joseph Tauriello.

APPROVAL OF TOWNSHIP COMMITTEE MEETING MINUTES

A motion by Herman, seconded by Kwasnik, to approve the Committee's 7/12/2021 Regular Meeting and Executive Session minutes were approved by voice vote.

TOWNSHIP COMMITTEE LIAISON REPORTS

Committeeman Kwasnik stated he spoke with DPW Director Jay Trstensky regarding the lights for 'Light It Up Gold' and that the current bulbs are either LED or larger and are hard to change. Committeeman Kwasnik noted he would ask again if there is anything else that can be done such as film over the current lights.

Committeeman Kwasnik noted that there is a schedule in place for the maintenance of the dirt roads in town, however DPW has been behind due to available manpower.

Committeewoman Lockwood stated that the County has done a Pipeline Resolution for opposing the Pipeline and suggested that the Township do the same.

Committeewoman Lockwood noted that Open Space is still looking for a coordinator.

Committeeman Herman stated that he spoke with East Amwell and an agreement was made to do shared service and this way there would be more candidates applying for a more desirable position.

Committeeman Vocke stated that the Board of Education decided to have all students and teachers wear masks for the school year.

Committeeman Herman noted the Fishing Derby was very successful at Copeland Farm and had a great turnout.

Committeeman Herman stated that renovations are finishing up at Town Hall and a soft opening date to open to the public would be Monday, August 23rd.

Mayor Waltman noted a correspondence from the Quarry Compliance Committee to waive the annual inspection and request that it be done by ordinance as the quarry is not currently operating.

A motion by Herman, seconded by Kwasnik for a waiver for the annual inspection of the quarry was unanimously approved by voice vote.

Mayor Waltman noted that Josh Petrucelli recently passed away and that he and his wife, Casey, are the residents who bought and erected the permanent 'Christmas' tree in the Village Green. Mayor Waltman inquired if the Committee wished to dedicate the tree to Mr. Petrucelli as well as get a plaque or a bench for the area. The Committee all agreed and Deputy Clerk Crivelli was tasked with researching this.

A motion by Herman, seconded by Kwasnik to not exceed \$200 for a plaque and/or bench was unanimously approved by roll call vote.

Public Hearing on Ordinance No. 2021-07

Mayor Waltman read Ordinance No. 2021-07 by title.

**Delaware Township
Ordinance No. 2021 – 07**

**An Ordinance to Amend Chapter 260-1 of the Code of the Township of Delaware Entitled
“Intoxication in Public or Semipublic Places; Nudity; Indecent Acts Prohibited.”**

§260-1 Intoxication in public or semipublic places; nudity; indecent acts prohibited.

No person shall appear in any street, sidewalk, ally, park or other public place, quasi-public place to which the public is invited in a drunken or intoxicated condition, or in a state of nudity, or make any indecent exposure of his or her person or be guilty of any other lewd or indecent act of behavior, or exhibit, sell or offer to sell any indecent or lewd item or thing or exhibit or perform in public any lewd act or other representation.

A motion by Herman, seconded by Vocke to open Ordinance #2021-07 for public hearing was unanimously approved by voice vote.

Hearing no members of the public speak up, a motion by Herman, seconded by Vocke to close Ordinance #2021-07 for public hearing was unanimously approved by voice vote.

A motion by Herman, seconded by Lockwood to adopt Ordinance #2021-07 was approved by roll call vote.

Mayor Waltman read Ordinance No. 2021-08 by title.

**Delaware Township
Ordinance No. 2021 – 08**

**An Ordinance by The Township of Delaware in Hunterdon County, New Jersey Amending
Section 7-3 of the Delaware Township Municipal Code to Include Permit Parking in
Designated Area**

WHEREAS, residents of the Township of Delaware have been negatively impacted by non-resident parking in certain residential communities; and,

WHEREAS, certain communities have Home Owner’s Associations (HOA) that wish to regulate parking within their community for the general health safety and well-being of its residents.

NOW THEREFORE, BE IT ORDAINED, by the Governing Body of the Township of Delaware in the County of Hunterdon, State of New Jersey, as follows:

1. Section 7-3 of the Delaware Township Municipal Code is hereby amended by adding a new paragraph (10) entitled §7-3.10 Parking by Permit Only which states as follows:

“No person shall park a vehicle upon Paulmier Road, or any part thereof, without first obtaining a parking permit issued through the HOA and visibly displayed within the vehicle. Any person convicted of violating the provisions of this chapter shall be liable to a penalty of \$50.00”

2. Any article, section, paragraph, subsection, clause, or other provision of the Delaware Township Code that is inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

3. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

4. This ordinance shall take effect upon its passage and publication and filing with the Hunterdon County Planning Board, and as otherwise provided for by law.

A motion by Herman, seconded by Vocke to open Ordinance #2021-08 for public hearing was unanimously approved by voice vote.

Chuck Cline, Upper Creek Road, inquired about the costs. Mayor Waltman stated this would be handled by the Home Owners Association.

Richard McComber, 33 Haines Road, inquired on his concerns with it being a public road and if residents would be notified prior to it taking affect. Committeeman Herman noted that the ordinance is the best option to help residents feel comfortable and safe and have the residents and the police work together. Mayor Waltman noted that children were starting to be verbally abused and that something needed to be done before it escalates more. Committeeman Herman also noted residents would be notified.

Hearing no other members of the public speak up, a motion by Herman, seconded by Kwasnik to close Ordinance #2021-08 for public hearing was unanimously approved by voice vote.

A motion by Herman, seconded by Kwasnik to adopt Ordinance #2021-08 was approved by roll call vote.

**Delaware Township
Ordinance No. 2021 – 09**

A Capital Ordinance of the Township of Delaware, County of Hunterdon, And State of New Jersey to Authorize an Expenditure and Appropriation from The Capital Improvement Fund for The Purchase of Road Improvements in The Amount of \$108,000.00.

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon, and State of New Jersey as follows:

Section 1. Delaware Township has a need to chip, tar and make improvements on various roads including but not limited to Dunkard Church Road, Haines Road, Yard Road, Britton Road, and Biser Road in Delaware Township in order to maintain our road system. Delaware Township hereby authorizes an appropriation and expenditure for labor and materials to make improvements on various township roads, in an amount not to exceed \$108,000.00; and,

Section 2. Total amount to be expended from the capital improvement fund shall not exceed \$108,000.00.

Section 3. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.

Deputy Mayor Vocke noted there have been a few changes in the DTMUA opening up membership spots to be able to move up an alternate and that Dwain Floyd is an expert on what the DTMUA needs.

A motion by Herman, seconded by Lockwood to approve T. Soltis and D. Floyd as members of DTMUA was unanimously approved by voice vote.

Mayor Waltman noted a Special Event application for Bridge Velo, LLC Bicycle Race on August 22, 2021.

A motion by Herman, seconded by Kwasnik for approval of the Special Event application was unanimously approved by voice vote.

Mayor Waltman stated that originally the Township fireworks were scheduled for September 11th, however that day holds a lot of meaning and the Township Committee felt compelled to have the Recreation Commission change the date to September 18th.

Mayor Waltman noted a request from the Recreation Commission for Tailgating by adults of legal drinking age and extending the use of Dilts Park beyond dusk for the fireworks on September 18th was received.

A motion by Herman, seconded by Lockwood to approve tailgating and extending the use of hours for the fireworks on September 18th was unanimously approved by roll call vote.

Liza Davis, Chair of the Historic Advisory Committee, addressed the Township Committee about the duties of the Historic Advisory Committee and commented that there is no clear mission in place and noted what was drafted over 10 years ago, needs clarification. The Committee agreed and advised they would look into this matter and compile a draft for the responsibilities as well as the lines of communications between the various committees and boards within the Township, County and State.

Mayor Waltman noted that although the HAEC is a controversial topic, and several residents have been confused with the communications by the HAEC and energy suppliers, he agrees that the program has provided energy savings and that the benefits outweigh the negatives.

Committeewoman Lockwood agreed and noted they need to be reminded to not use Township letterhead or names, but still let people know this is not a scam and to have everything open and transparent.

Mayor Waltman noted that residents are more knowledgeable on the program now and noted we have a better website in place for communications.

Committeewoman Lockwood noted that anyone can opt out at any time as well.

Committeeman Herman stated this is not the business the Township should be involved in and the residents should choose their own different ways to save and go greener privately. Committeeman Herman noted that some residents received abnormally high bills that was sanctioned by the Township.

Committeewoman Lockwood stated that the high bill was due to the payment program, not the HAEC.

Committeeman Herman noted that regardless, residents still hold the Township responsible and the Township is the one receiving the phone calls.

Committeeman Vocke agreed with Committeeman Herman, however felt that it should be left for now.

A motion by Lockwood, seconded by Vocke to approve the HAEC program for another year was approved by roll call vote.

Mayor Waltman explained Engineer Roseberry stated there was no eminent danger, nothing could be done immediately and that there is no need to worry.

Committeeman Vocke stated that he and his wife are expecting a baby in December.

Mayor Waltman noted that regarding the minutes, residents do have a voice, but that it is hard to keep everyone happy. Township Attorney Tauriello stated that the Committee decided at the Reorganization that Robert's Rules are to be followed and that the minutes are in accordance with that. Township Attorney Tauriello stated that he hopes residents are not coming to the meetings just to see their name in minutes. Township Attorney Tauriello noted the Committee has listened and took the input from residents and that there is no need for the minutes to change. Township Attorney Tauriello stated if residents wanted verbatim, they could OPRA request the recordings.
