Mayor Waltman announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat, Trenton Times, and the Star Ledger, was posted on the bulletin board in the Municipal Building and filed with the Township Clerk on January 11, 2022.

## **APPROVAL OF TOWNSHIP COMMITTEE MEETING MINUTES**

March 14, 2022 Regular and Executive Session meeting minutes were tabled.

#### **TOWNSHIP COMMITTEE LIAISON REPORTS**

Committeewoman Lockwood stated the Environmental Commission and Shade Tree commission talked about the replacement of trees after the loss of the Ash trees.

Committeewoman Lockwood noted the Stormwater Subcommittee went to the Public Works and Police Department to check the area for potential future flooding. Committeewoman Lockwood stated there was a lot of potential to improve the area and they would be looking into potential grants.

Committeewoman Lockwood reported the next newsletter for June – August has a deadline of the end of April.

Committeeman Bower reported that the Quarry Compliance Committee and the Planning Board reviewed the hydro data for the quarry renewal license set to expire in June. Committeeman Bower noted Engineer Sterbenz inspected the quarry on April 4<sup>th</sup>, and his report should be completed by the end of the month.

Mayor Waltman noted that some of the FEMA projects that have been completed have been submitted by OEM. Mayor Waltman stated it is still unknown when the Township will receive the FEMA funding reimbursement.

Mayor Waltman stated Lower Creek Road project s going to bid for the plantings and trees for the embankment stabilization. Mayor Waltman noted planting should be completed by Memorial Day and that paving should take place around the same time.

Deputy Mayor Herman advised that the Recreation Commission posted events on the Township website. Deputy Mayor Herman noted the Egg Hunt had a good attendance.

Deputy Mayor Herman suggested the Township considers allowing the Delaware Township Athletic Association to make changes to Makara Field for field hockey use and lacrosse and to work with Public Works as needed.

WHEREAS, pursuant to NJAC 5:30-7.2 thru 7.5 the Township of Delaware has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township meets the necessary conditions to participate in the program for the 2022 budget year, so now therefore

BE IT RESOLVED, by the Governing Body of the Township of Delaware that the in accordance with NJAC 5:307.6a & b and based upon the Chief Financial Officers certification. The governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to NJSA 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met (Complies with the "CAP" law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and NJAC 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated
  - b. Items of appropriation are properly set forth
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality
- 5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of NJSA 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

#### Delaware Township Resolution #2022-67 Debt Policy

WHEREAS, the Committee of the Township of Delaware recognizes the need to establish a debt policy to prudently manage indebtedness incurred by the Township; and

WHEREAS, the Township of Delaware is subject to the oversight of the Department of Community Affairs, the Local Finance Board and the New Jersey Statutes (N.J.S.A. 40A:2-Local Bond Law; and

WHEREAS, the Township of Delaware is restricted by State Statute as to limitations on net debt, to, generally, 3.5% of the Borough's three-year average equalized evaluation; and

WHEREAS, the Township of Delaware is similarly restricted by State Statute with regard to limitations on capital items to be financed, amortization requirements and length of borrowing term; and

WHEREAS, in addition to the limitations set forth by State Statute, the Delaware Township Committee recognizes the need to detail and adopt a DEBT POLICY based on best practices, historic debt issuance, and future capital plans; and

WHEREAS, the Township has evaluated historic debt issuance, and the now current Capital Budget.

NOW, THEREFORE, BE IT RESOLVED THAT

- 1. The Township of Delaware shall, as a goal, maintain debt target
  - a. For which total net debt is no greater than 3.5% of the equalized ratable value, and/or
  - b. For which annual debt service is no greater than 25% of the previous year's operating expenditures and/or

- 2. When issuing debt, the Township will take into consideration the following guidelines in structuring the repayment of debt:
  - a. Level or gradual debt service without "spikes" with initial funding through temporary notes to be financed permanently on a regular basis.
  - b. Borrowing terms that are less than the average useful life of the ordinances financed and with a goal of maintaining a 65% retirement level of principal within ten years.
- 3. On advice from its Municipal Advisor and Bond Counsel, the Township of Delaware will issue refunding bonds, as permitted by applicable State and Federal regulations, for previously issued debt when such refunding will produce a savings equal to at least 3% of the par value of the debt being refunded, as measured on a net present value basis.
- 4. The Committee of the Township of Delaware covenants that the Township will agree to comply with any Continuing Disclosure Agreement for the benefit of the holders of any of its existing publicly traded bonds, and the secondary market disclosure requirements of the Securities and Exchange Commission's Rule 15c2-12.
- 5. As part of the annual budget process, the Township Committee shall consider the capital needs of the Township and evaluate the impact of the Capital Budget on the net debt target and forward debt service. If the adoption of the Capital Budget materially impacts the net debt target, the Township Committee may, after deliberation, adopt a resolution amending the DEBT POLICY.

CFO McDaniel advised the Township Committee with the following:

This budget reflects a once cent increase in municipal taxes, On an average home of \$423,000 the increased cost is \$42.30 or \$10.60/quarter.

A penny in 2022 equals about \$81,000.

Our challenges this year included the IDA storm costs incurred in 2021 raised this year's budget amount \$310,000.

Once again we are not adding services, cutting where we can but also providing for the very real cost increases that we are all facing these days.

Our revenues are still down from the effects of COVID.

Fortunately, we were able to use additional fund balance to offset the emergency costs of IDA and still remain in keeping with our formal fund balance policy. We anticipate FEMA reimbursement to cover the storm costs not at a 90% reimbursement.

Our collection rate is still holding at 98.1%

Our debt is organized, funded, and manageable and within the parameters of our formal debt policy at less than a 1% ratio.

We have capital improvement funds in the amount of \$100,000 plus the ARP (\$430,000) a sorely needed insurance measure for projects and emergencies.
