

DELAWARE TOWNSHIP COMMITTEE REGULAR MEETING MINUTES

MAY 9, 2022 at 7:30 PM

In Person

Mayor Waltman called the regular meeting of the Delaware Township Committee to order on May 9, 2022 at 7:30 PM. Mayor Waltman announced that this meeting is called pursuant to the provisions of the Open Public Meetings Act. Notice of this meeting was faxed to the Hunterdon County Democrat, Trenton Times, and the Star Ledger, was posted on the bulletin board in the Municipal Building and filed with the Township Clerk on January 11, 2022.

PLEDGE OF ALLEGIANCE

Mayor Waltman led those in attendance in the pledge to the nation's flag.

ROLL CALL

Present: Mayor James Waltman, Deputy Mayor Charles Herman, Committee Members Chad Bower, Joseph Vocke and Susan Lockwood, along with Township Clerk Maria Andrews, Deputy Township Clerk Tiffany Crivelli, and Township Attorney Joseph Tauriello.

EMPLOYEE RECOGNITION

The Township Committee recognized William Powell and Deanna Higgins for their hard work and dedication throughout the year as well as working diligently with FEMA for the aftermath of Hurricane Ida.

APPROVAL OF TOWNSHIP COMMITTEE MEETING MINUTES

A motion by Herman, seconded by Bower to approve the March 14, 2022 Regular and Executive Session meeting minutes was unanimously approved by voice vote.

TOWNSHIP COMMITTEE LIAISON REPORTS

Committeewoman Lockwood stated the Stormwater Subcommittee looked into "naturalizing" the area by the Department of Public Works and that there may be a grant available.

Deputy Mayor Herman noted the website has been updated with a lot of events such as the Fishing Derby on June 25 and the Plant Swap on May 22. Deputy Mayor Herman also mentioned June 11 is Delaware Day at the Somerset Patriots offering discounted tickets.

Committeeman Bower stated the Quarry Compliance Committee noted four items during the Engineers inspection, and as of May 3^{rd} , all items were addressed except one which was in the process.

Mayor Waltman noted Township Engineer Adam Wisniewski is working with FEMA regarding Lower Creek Road and Sandbrook Headquarters Road for the permanent repairs to limit damage from future storms.

Mayor Waltman stated the contract was awarded for the plantings along the Lower Creek Road embankment and work is tentative to begin May 16th.

Chuck Cline, 22 Reading Road, inquired about the Locktown Stone Church.

INTRODUCTION/PUBLIC HEARING ON ORDINANCES Introduction to Ordinance #2022-04

Mayor Waltman read Ordinance #2022-04 by title.

Delaware Township Ordinance No. 2022-04

An Ordinance by The Township of Delaware in Hunterdon County, New Jersey Amending Sections 84-5, 84-6 And 84-7 Of The Delaware Township Municipal Code Regarding the Duties and Qualifications of the Director of Public Works

WHEREAS, Delaware Township is desirous to clarify the duties and qualifications of the Director of Public Works.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Delaware in Hunterdon County, State of New Jersey, as follows:

- 1. Section 84-5 of the Delaware Township Municipal Code is hereby amended as follows:
 - a. Responsible for planning, scheduling, directing, controlling and coordinating the daily and long term operations of public works activities, as applicable, including the utilization of manpower, equipment, materials, funds, and other available resources.
 - b. Reports to Public Works Commissioners and is responsible for supervising and coordinating the road maintenance work, road construction, and care and maintenance of Township buildings and property.
 - c. Supervises the activities of the Public Works Manager to ensure compliance with established policies and procedures.
 - d. Develops appropriate work programs and schedules for development and maintenance work on Township properties.
 - e. Prepares estimates and requests for needed materials, equipment, tools and supplies and places orders for such as required.

- f. Has responsibility for obtaining estimates and quotations for work to be performed on Township properties other than road maintenance work.
- g. Supervises and inspects the work performed on Township properties to ensure compliance with established policies, procedures and methods.
- h. Serves as the Township Recycling Coordinator and the Clean Communities Coordinator.
- i. Investigates complaints from the public, Township employees and the Township Committee via the Public Works Commissioners.
- j. Prepares factual monthly reports containing findings, conclusions and recommendations and then submits these reports directly to the Public Works Commissioners, as appropriate.
- k. Acts to foster harmonious relations between Township employees, contracted Township employees, Township volunteers and the general public.
- l. Safeguards Township property under their control and maintains essential records and files.
- m. Maintains necessary cost records and prepares annual budget recommendations for Public Works for submission to the Township Committee.
- n. Approves Public Works annual budget as submitted by the Public Works Manager for sending to the Township Committee.
- o. Shall receive authorization from the Township Committee before hiring new employees.
- 2. Section 84-6 of the Delaware Township Municipal Code is hereby amended to read "Director of Public Works Qualifications".
- 3. Section 84-7 of the Delaware Township Municipal Code is deleted in its entirety.
- 4. Any article, section, paragraph, subsection, clause, or other provision of the Delaware Township Code that is inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.
- 5. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.
- 6. This ordinance shall take effect upon its passage and publication and filing with the Hunterdon County Planning Board, and as otherwise provided for by law.

Delaware Township Ordinance No. 2022-05

An Ordinance of the Township of Delaware, County_of Hunterdon and State of New Jersey Amending and Supplementing Ordinance #2012-18 To Modify the Length of the Lease and the Renewal Thereof with The Friends of the Locktown Stone Church, Inc. Pertaining to The "Locktown Old School Baptist Church," Block 8, Lot 1 In The Township of Delaware

WHEREAS, the Delaware Township Committee adopted Ordinance #2012-18 on November 26, 2012 authorizing a lease and lease renewal with the Friends of the Locktown Stone Church, Inc.; and

WHEREAS, the Friends of the Locktown Stone Church, Inc. has applied to the New Jersey Historic Trust for grant funds to help preserve the Locktown Stone Church; and

WHEREAS, Hunterdon County maintains a policy for leased facilities that requires a lease hold interest of not less than fifteen years; and

WHEREAS, the current Lease Agreement and Addendum to Lease Agreement set the lease expiration date at December 29, 2029; and

WHEREAS, the Delaware Township Committee now desires to amend the length of the term of the lease and the subsequent lease renewals.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Delaware in Hunterdon County, New Jersey, as follows:

<u>Section 1. Lease of Block 8, Lot 1</u>. Pursuant to <u>N.J.S.A.</u> 40A:12-15, the Township Committee hereby authorizes the lease of Block 8, Lot 1 to The Friends of the Locktown Stone Church, Inc. ("Friends") for the purposes described in Ordinance #2022-05 subject to the following amended lease term length and lease renewal term length:

- A. Term: Fifteen (15) December 29, 2021 December 29, 2036
- B. Renewal period twenty (20) years December 29, 2036 December 29, 2046 provided the "Friends" remain in good standing under the terms of the Lease Agreement.
- C. Consideration: One (\$1.00) Dollar per year.
- D. Every year prior to December 29th, the "Friends" shall provide the Township Clerk with a certificate of liability, property, worker compensation, non-owned automobile, and allied insurances.

Section 2. All other Sections of Ordinance #2012-18 shall remain in full force and effect.

<u>Section 3. Severability</u>. The various parts, sections, and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section, or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

<u>Section 4. Repealer</u>. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

<u>Section 5. Effective Date</u>. This Ordinance shall take effect upon final passage and publication pursuant to law.

PUBLIC HEARING AND ADOPTION OF 2022 BUDGET Resolutions #2022-73 & #2022-74

CFO McDaniel, along with Laura Atwell CPA, PSA, RMA, advised the Township Committee with the following:

This budget reflects a one cent increase in municipal taxes. On an average home of \$423,000 the increased cost is \$42.30 or \$10.60/quarter.

Our challenges this year included the IDA storm costs incurred in 2021 raised this year's budget amount \$310,000.

Our debt is organized, funded, and manageable and within the parameters of our formal debt policy at less than a 1% ratio.

A motion by Herman, seconded by Bower to open Resolution #2022-73 for public hearing was unanimously approved by voice vote.

Chuck Cline, 22 Reading Road, inquired if inflation rates were taken into account.

CFO McDaniel responded, once again, we are not adding services. Cutting where we can but also providing for the very real cost increases that we are all facing these days.

Hearing no other comments from the public, a motion by Herman, seconded by Bower to close Resolution #2022-73 to public hearing was unanimously approved by voice vote

Delaware Township Resolution #2022-74 Local Budget Examination WHEREAS, NJSA 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination, and

WHEREAS, NJAC 5:30-7 was adopted by the Local Finance Board on February 11, 1997, and

WHEREAS, pursuant to NJAC 5:30-7.2 thru 7.5 the Township of Delaware has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township meets the necessary conditions to participate in the program for the 2021 budget year, so now therefore

BE IT RESOLVED, by the Governing Body of the Township of Delaware that the in accordance with NJAC 5:307.6a & b and based upon the Chief Financial Officers certification. The governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to NJSA 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met (Complies with the "CAP" law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and NJAC 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate, and correctly stated
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality

- 5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of NJSA 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

Award of Contract in Accordance with N.J.S.A. 40a:11-6 And N.J.A.C. 5:34-6.1 for Planting / Stream Bank Stabilization on Lower Creek & Sandbrook-Headquarters Roads

WHEREAS, tropical storm Ida caused severe weather conditions and flooding throughout the state of New Jersey for which Governor Murphy declared a state of emergency pursuant to Executive Order 259; and

WHEREAS, tropical storm Ida caused severe weather conditions and flooding within the Township of Delaware for which a local state of emergency was declared in accordance with New Jersey law to protect the health safety and welfare of all residents; and

WHEREAS, the local state of emergency has created circumstances requiring the immediate delivery of certain goods or the performance of services necessitating the awarding of certain contract without public bidding regardless of the public bid threshold to solely address the immediate needs of the emergency; and

WHEREAS, a need for services regarding stream bank stabilization work on Lower Creek Road and Sandbrook-Headquarters Road exist; and

WHEREAS, N.J.S.A. 40A:11-6 and N.J.S.C. 5:34-6.1 as referenced in Local Finance Notice 2021-15 allows in circumstances where an emergency is affecting the public health, safety or welfare and requires the immediate delivery or performance of services, a contract may be awarded without public bidding regardless of the bid threshold; and

WHEREAS, the Township Engineer has recommended that a contract be awarded to Wetlands, Inc for the limited purpose of stream bank stabilization work on Lower Creek Road and Sandbrook-Headquarters Road; and

WHEREAS, the Township of Delaware, in the County of Hunterdon, New Jersey has deemed the stream bank stabilization work on Lower Creek Road and Sandbrook-Headquarters Road an immediate need of the emergency.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of Delaware Township, that Wetlands, Inc be awarded in accordance with N.J.S.A. 40A:11-6 and N.J.S.C. 5:34-6.1 to perform the stream bank stabilization work on Lower Creek Road and Sandbrook-Headquarters Road in the amount not to exceed \$39,950.00.

WHEREAS, the Township Committee approved to enter into a five-year Farming Service Agreement with Joseph Cooper to farm a portion of Block 42, Lot 3.02, Lambertville Headquarters Road; and

WHEREAS, Green Acres permits a five-year agreement pursuant to N.J.A.C. 7:36-25.13(b)4i.

Pursuant to N.J.A.C. 7:36-25.13, the Clerk is hereby directed to submit a copy of said agreement to the New Jersey Department of Environmental Protection, Green Acres Program for its review and approval at least 45 days prior to the agreement's execution, or such agreement will be deemed by Green Acres to be null and void.
- 3. The Township through its appropriate staff and officials is hereby authorized to undertake any and all other acts as may be proper and necessary to effectuate the terms of this resolution.

- 4. A copy of this Resolution, the Certification of Contract Value, the Campaign Contributions Affidavit, and the executed Agreement shall be placed on file in the office of the Township Clerk.
- 5. Joseph Cooper must adhere to all terms and conditions to Resolution #2022-71 as well as the Township of Delaware Maintenance and Farming Services Agreement.

Delaware Township Resolution #2022-72 Declaring Friday, June 3, 2022 as National Gun Violence Awareness Day

WHEREAS, every day, more than 110 Americans are killed by gun violence, alongside more than 200 who are shot and wounded, and on average there are nearly 16,000 gun homicides every year; and

WHEREAS, Americans are 26 times more likely to die by gun homicide than people in other high-income countries; and

WHEREAS, New jersey has an average of 454 gun deaths every year; and

WHEREAS, gun homicides and assaults are concentrated in cities, with more than half of all firearm related gun deaths in the nation occurring in 127 cities; and

WHEREAS, cities across the nation, including Delaware Township, are working to end the senseless violence with evidence-based solutions; and

WHEREAS, protecting public safety in the communities they serve is mayors' highest responsibility; and

WHEREAS, support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with keeping guns away from people with dangerous histories; and

WHEREAS, mayors and law enforcement officers know their communities best, are the most familiar with local criminal activity and how to address it, and are best positioned to understand how to keep their citizens safe; and

WHEREAS, gun violence prevention is more important than ever as the COVID-19 pandemic continues to exacerbate gun violence after more than two years of increased gun sales, increased calls to suicide and domestic violence hotlines, and an increase in city gun violence;

WHEREAS, in January 2013, Hadiya Pendleton was tragically shot and killed at age 15 and on June 3, 2022 to recognize the 25th birthday of Hadiya Pendleton (born: June 2, 1997), people across the United States will recognize National Gun Violence Awareness Day and wear orange in tribute to Hadiya Pendleton and other victims of gun violence as well as the loved ones of those victims; and

WHEREAS, the idea was inspired by a group of Hadiya's friends, who asked their classmates to commemorate her life by wearing orange; they chose this color because hunters wear orange to announce themselves to other hunters when out in the woods and orange is a color that symbolizes the value of human life; and

WHEREAS, anyone can join this campaign by pledging to wear orange on June 3rd, the first Friday in June in 2022, to help raise awareness about gun violence; and

WHEREAS, by wearing orange on June 3, 2022 Americans will raise awareness about gun violence and honor the lives of gun violence victims and survivors; and

WHEREAS, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe.

NOW, THEREFORE BE IT RESOLVED, that Mayor Waltman of Delaware Township declares the first Friday in June, June 3, 2022, to be National Gun Violence Awareness Day.

- 1. The Township Committee of the Township of Delaware hereby authorizes the execution of an Agreement with the Morris County Cooperative Pricing Council by the Township of Randolph as Lead Agency dated October 1, 2021 pursuant to N.J.S.A. 40A:11-11(5). Said Agreement is to become a member of the MCCPC for a five (5) year period from October 1, 2021 through September 30, 2026.
- 2. The Delaware Township Clerk is hereby directed to submit a copy of this adopted Resolution, along with an executed Agreement, to Randolph Township as Lead Agency of the MCCPC.
- 3. This Resolution shall take effect immediately upon final passage according to law.
- 4. All appropriate Delaware Township officials are authorized and directed to perform all required acts to affect the purpose of this Resolution.
