TOWNSHIP COMMITTEE LIASON REPORTS

Committeeman Bower commented that he had reviewed the Quarry and groundwater reports with the Township Engineer and noted a follow up inspection is scheduled for 8/12/22.

Committeeman Vocke noted that he spoke with Mayor Nemeth in Stockton regarding the reopening of Worman Road. He explained Stockton is waiting to hear back from FEMA regarding potential funding.

Committeewoman Lockwood noted the Open Space Committee will meet later this month to finalize their review of the Farmland Plan. She also commented that the Shade Tree Committee took note of trees in the rear of the Higgins Farm that are dead. She stated the Committee is requesting they be removed and will try to get new trees for replanting. Lastly, Ms. Lockwood reported that the Stormwater Committee is not holding a meeting in August.

Deputy Mayor Herman noted the following upcoming events:

8/20/22 – Kite Festival at Dilt's Park

9/10/22 – Fireworks at Dilt's Park

10/1/22 – Block Party

Mayor Waltman noted that the County approved the requested reduced speed of 25 mph though the center of town. He also reported that the Township was awarded a \$5000 "Rediscover"

Hunterdon" grant which will be used to help fund the Block Party. Additionally, Mayor Waltman commented that he requested the County create additional parking spaces in front of the Municipal Building, Farmers Market and a few ADA compliant parking spaces for the post office when they repave County Route 604. Lastly, he stated he wrote a letter to the County requesting the Hamp Road bridge be reopened.

OPEN TO THE PUBLIC FOR ITEMS ON THE AGENDA

The following members of the public came forward, each commenting on items *not* on the agenda:

Lynn Hulme of 208 Lower Creek Road came forward and expressed concern over the newly planted trees and grass seed associated with the restoration project that will likely die if they are not watered. Engineer Wisniewski stated he had recently done an inspection of the area and remarked that many of the plantings seem to be doing well, but agreed the drought is not helping the situation.

Ann Robbins of 122 Lower Creek Road came forward and asked for clarification on what sections of Lower Creek Road will be repaired. Engineer Wisniewski stated they are hoping to award a BID in September to complete the restoration project.

Christian Van Stolk of 110 Sandbrook Headquarters Road came forward and provided a very emotional statement about his dachshund, Fred, who was recently killed by a speeding truck on Sandbrook Headquarters Road. He asked the Committee to do something about the situation and suggested speed bumps be installed.

Diana Garabaldi of 142 Sandy Ridge Road came forward and expressed opposition to the scheduled fireworks in Dilt's Park. She noted concern for noise, air pollution and potential fire risk due to the drought.

Seeing no other members of the public come forward, Mayor Waltman closed the floor to public comment.

Delaware Township Resolution #2022-95 Fireworks at Sarah Dilts Park

WHEREAS, the Delaware Township Recreation Commission has requested permission to have Garden State Fireworks, Inc. hold a fireworks display for the Delaware Township Fall Fireworks at Sarah Dilts Farm Park on September 10, 2022 (rain date September 17, 2022), in the amount of \$8,000.00 (excluding Fire Permit Fees); and

WHEREAS, the Delaware Township Recreation Commission has requested permission to have tailgating by adults of legal drinking age between the hours of 4:00 pm and 8:00 pm at the Fall Fireworks at Sarah Dilts Farm Park; and

WHEREAS, the Delaware Township Recreation Commission has requested permission to extend the hours of use of the park beyond the Dusk closing time to permit the enjoyment of the fireworks; and

WHEREAS, the Township Committee believes that it is appropriate to grant permission for such display and requests, having given notice of the event to the Township's insurance carrier, having identified Garden State Fireworks, Inc. as the vendor, having provided to the Township's insurance carrier proof of insurance for Garden State Fireworks, Inc. and confirmation that the Township of Delaware is named as an additional insured, and having otherwise addressed any issues or concerns of the Somerset County Joint Insurance Fund.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Delaware that permission is granted to have Garden State Fireworks, Inc. conduct a fireworks display during the Fall Fireworks at the Sarah Dilts Farm Park on September 10, 2022 (rain date September 17, 2022) provided that it satisfies all comments and concerns, if any, of the State of New Jersey Department of Community Affairs Division of Fire Safety, the Sergeantsville Volunteer Fire Department, the Delaware Township Police Department, and/or any other regulatory agency or body identified and/or issued prior to or on the evening of the display including that relating to weather conditions at the time of the display; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, by the Township Committee of the Township of Delaware that permission is grated to allow tailgating at the Fall Fireworks at Sarah Dilts Farm Park on September 10, 2022 (rain date September 17, 2022) and permit adults of legal drinking age to transport and consume alcoholic beverages to be limited to beer and/or wine, and whom shall not provide, disseminate, or distribute any alcoholic beverage to an under-age person; and

Delaware Township Resolution #2022-96 Childhood Cancer Awareness Month

WHEREAS, In September 2019, Congress passed a resolution making September Childhood Cancer Awareness Month; and

WHEREAS, according to the American Childhood Cancer Association, 1 in 285 children in the United States will be diagnosed with cancer before the age of 20 years old; and

WHEREAS, cancer is the leading cause of death from disease and the second overall leading cause of death for children in the United States; and

WHEREAS, the causes of most pediatric cancers are unknown and likely not preventable; and

WHEREAS, each year an estimated 15,780 in the United States and more than 300,000 children under the age of 19 globally, are diagnosed with a form of childhood cancer; and

WHEREAS, every year more than 1,700 children in the United States, and 328,000 children under the age of 19 globally, lose their lives to cancer; and

WHEREAS, according to the National Cancer Institute, two-thirds of childhood cancer survivors are at risk for or experience side effects such as secondary cancers, heart damage, lung damage, infertility, chronic hepatitis, alterations in growth and development, impaired cognitive abilities, and psycho -social impairments like severe anxiety and behavioral problems; and

WHEREAS, one-quarter of all survivors will face a late-effect from treatment that could be considered severe or life-threatening; and

WHEREAS, cancer patients face a higher risk of contracting the Coronavirus Disease 2019 (COVID-19) due to a weakened immune system; and

WHEREAS, families who have experienced or been affected by childhood cancer continue to advocate for more awareness, funding, and research for prevention and treatment; and

WHEREAS, cancer occurs regularly and randomly and spares no racial or ethnic group, socioeconomic class, or geographic region.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of Delaware Township, Hunterdon County, State of New Jersey, that September is declared Childhood Cancer Awareness Month, honors the children whose lives have been lost to cancer, offers condolences to the families of those children, celebrates survivors, and advocates for more research on the prevention and treatment of pediatric cancer.

NEW BUSINESS/OTHER

Historic Advisory Committee Project Presentation

Liza Davis, Chair of the Historic Advisory Committee presented a refurbished "Delaware Township" sign that was re-done with gold leaf lettering by Chuck Taylor. The Committee

expressed appreciation for the beautiful job and commented that it will be hung in the hallway of the Municipal Building.

Approval to Remove Z. Burger as Alternate II on the Environmental Commission and Appoint J. Goldman to Fill the Vacancy

It was noted for the record that Mayor Waltman approved the suggested change.

Acknowledge Environmental Commission Correspondence, re: Pollinator Garden at Dilt's Park

It was noted for the record that the Committee supported the location of the proposed fenced in pollinator garden near the mower shed, at the edge of the parking lot nearest the Snack Shack at Dilt's Park.

Discussion/Approval of Placement for a Sign for the Girl Scouts Local Crop Box

Mayor Waltman explained the box was taken from the telephone pole and he was going to reach out to the DPW and suggest a new box be mounted on a post in the grassy area between the entrance and exit cuts of the municipal building parking lot. It was noted for the record that the Committee supported the proposed new location.

Discussion on Capital Improvement Funding for Dilt's Park/Discussion on Bathroom Renovations for Dilt's Park

CFO Diane McDaniel explained the Committee needs to introduce a capital ordinance allotting a sum of money to cover the cost to renovate and repair the bathrooms at Dilt's Park along with hiring a park planner and addressing the other necessary repairs to park equipment like the tennis courts. Mayor Waltman suggested the maximum amount allowed be allotted. He remarked the County has approximately \$82,000 set aside for Delaware Township that would be put back into the Open Space fund.

There was a fervent discussion between Committeewoman Lockwood, Mayor Waltman and Deputy Mayor Herman on the referendum and how Ms. Lockwood believed the open space funds were intended to be used.

Mayor Waltman suggested an ordinance authorizing the use of the maximum allowed amount be on the Committee's next agenda. Committeewoman Lockwood requested a Park Planner be hired so the details of the park repairs are clear. Mayor Waltman remarked the Township doesn't need a Park Planner to determine that the bathrooms need to be repaired, but rather they need a plumber.

Deputy Mayor Herman commented that the Committee had indicated they wished to have a direct liaison to work with the Department of Public Works as the Park Planner and stated there is no hurry to get a planner until the Township hires someone for DPW.

OPEN TO THE PUBLIC

Mayor Waltman opened the floor to public comment.

Al Abetsky of 129 Sergeantsville Road came forward and asked for an update on the neglected properties within the Township. Mayor Waltman noted that he is working with the Deputy Clerk to draft letters that will be sent to the County Board of Health on this matter. He noted the list of neglected properties will be coming from Police Chief Cane.

Jess Stahl of 38 Dunkard Church Road came forward and requested the bathrooms and portapotties at Dilt's Park be checked prior to the kite festival. Mayor Waltman stated he will speak with the DPW regarding this matter. Additionally, Ms. Stahl commented that the flags on the pole at the municipal building need to be replaced. Deputy Mayor Herman indicated the Township has the new flags and he will have it taken care of. Next Ms. Stahl asked if the Township had received the \$40,000 state grant. CFO McDaniel stated the Township Engineer is looking into the parameters on how the funds can be used. Lastly, Ms. Stahl asked about the overgrown vegetation on the "s" curves on Dunkard Church Road noting the property owner had 30 days to rectify the situation. Mayor Waltman remarked he would follow up on the issue. Finally, Ms. Stahl asked for clarification on the A1 Ag Zone referring to the Zoning Board voting against the tennis facility but in favor of another business, M&W. Mayor Waltman explained that M&W is a commercial use on what was an industrial property whereas having an agricultural use become a tennis facility is a very different thing.

Seeing no other members of the public come forward, Mayor Waltman closed the floor to public comment.

FINAL COMMENTS OF THE TOWNSHIP COMMITTEE

Deputy Mayor Herman commented that since the QCC was such a big issue he requested that Ms. Katz organize the boxes of files on this matter. He also referred to the email about the Delaware Township Historic Society President who is intervening with the County and representing that he is working on behalf of the Township and attempted to stop a project on Route 604. Deputy Mayor Herman remarked that the Historic Society is a 501-3c organization that gets \$3000 from the Township. Committeewoman Lockwood clarified that the money is because they provide reports on historic properties. She said they get paid to do a task. Mayor Waltman commented that the Township should not be giving them money if their President is claiming to have authority over the Township because he believes that to be problematic.

Diana Garabaldi of 142 Sandy Ridge Road asked if the article on the Delaware Township Facebook page about the coyote can be put on the Township website. Mayor Waltman said he would check into having it posted on the website.

Valerie Tucci of 21 Sandy Ridge Road commented that she believed the money for the Historical Society was to do work on the schoolhouse.
