A motion by Herman, seconded by Lockwood, to approve the Committee's 11/14/22 meeting minutes was approved by voice vote with no abstentions.

TOWNSHIP COMMITTEE LIAISON REPORTS

BOARD OF EDUCATION

Committeeman Vocke stated there is nothing to report at this time.

OPEN SPACE

Committeeman Herman stated that he was not in attendance at the last meeting. Committeewoman Lockwood reported that they finished the Agricultural Plan and discussed the next steps for the future.

STORMWATER COMMITTEE

Committeewoman Lockwood reported the following:

- The Committee Chair was out of town so they did not meet.
- Spoke to Adam regarding the continuing issues with the New Jersey Conservation Foundation, (NJCF) and it seems as though they may be moving forward.

Mayor Waltman reported the following:

- Tim Morris of the NJCF has signed a letter approving our work on Lower Creek without any restrictions. We are cleared to go 100%
- The work should be completed well in advance for the Township to receive its FEMA funding.
- I'm happy this has been approved, but disappointed in the speed in which it was processed, there was a lot of unnecessary back and forth which caused delays and put the Township at risk of losing the funding.

Deputy Mayor Herman stated that over the years we have bent over backwards to assist NJCF and we seem to get push back when we need something.

RECREATION COMMITTEE

Deputy Mayor Herman reported the following:

- The tractor parade took place over the weekend. DTAA worked the grill, and it was a successful event.
- The Holiday light contest being judged downstairs right now. Approximately twenty (20) homes entered and they are quite impressive.

QUARRY COMMITTEE

Committeeman Bower reported that the following:

- Last month I reported that we drafted a memo to Colliers outlining exactly what needs to be provided to us to satisfy the conditions. This memo was sent on November 22, 2022.
- We also gave them a copy of the 2012 report.
- The second meeting will take place on the 19th with our Acting Clerk to review the files that should be there.

PUBLIC WORKS

Mayor Waltman introduced Amanda Khan as the new Director of Public Works. She comes to us from Jersey City with 25 years of experience. We are happy to have her and although she has only been here for one week, she has a report to share.

Ms. Khan shadowed the DPW crew last week and provided a report including and not limited to the following:

- Cold patching was done on several Township roads;
- A tree was removed at Dilts Park and the clippings were hauled to DPW;
- Dead branches were cleared by soccer field 8:
- Tree Branches trimmed on a few roads:
- · Repairs were done on Township vehicles;
- Visited Lower Creek Road today, noting that it is a contentious project. The projected end date from the Engineer is the end of April.
- The plan for Raven Rock Road was sent to us from the Engineer, the work will be done in house to save money.

RECREATION COMMISSION

The Meteor Watch is scheduled for this Friday from 5:00pm to 10:00pm at Dilts Park;

• The Holiday Tractor Parade through Sergeantsville to the Village Green along with the Tree Lighting is scheduled for December 3rd at 4:30pm.

OPEN TO THE PUBLIC

Mayor Waltman opened the floor to public to express their thoughts for any items listed on the agenda.

Mayor Waltman noted that the Senate Bill regarding Firearms was an item added late to the agenda.

Marilyn Cummings of 348 Rosemont Ringoes Road and member of the Delaware Township Historic Society expressed her concern about the closing of the Sergeantsville Post Office and stated that the Historic Society stands ready to do whatever it can to assist.

Discussion ensued regarding:

- the possibility of a trailer Post Office;
- potential offers for the Post Office to relocate within Sergeantsville;
- the Post Office was seeking a fifteen-year lease, and the elderly property owners were not comfortable with the length of the lease;

Joe Wiley of 37 Lambert Road stated that he initiated the petition about three (3) weeks ago with about seventy (70) signatures and later received another twenty (20) to thirty (30) signatures. I originally sent it to the Postmaster General and was then given the name of the correct person it

should be sent to. Mr. Wiley noted that there was a cover letter which provided history and he read it into the record.

Mr. Wiley thanked Mayor Waltman for his involvement and gave the petition to Ms. McDaniel.

Mayor Waltman stated that this is a contract negotiation between a Federal Government Agency and a private property owner and we are sending this Resolution along with a petition signed by Township residents. This is all we can do.

Attorney Tauriello stated that from a legal standpoint, what is before the Committee tonight is all that they can do.

Ravenna Taylor of 43 Lambert Road asked about the Resolution pertaining to the gun law.

Chuck Cline offered that there are three (3) Board of Adjustment member terms expiring this year, Caine Fowler, Mike Manley and Cullen McAuliffe, and although he has not yet spoken to them, he thinks they will want to continue.

Ravenna Taylor of 43 Lambert Road expressed her concerns about lighting of the flagpole and the cost to the Township.

Gail Conover of 60 Covered Bridge Road expressed her support of the flagpole noting it can be used for many different things. The lighting goes directly up the flagpole and does not shine into any windows. It is a good thing for our youth and our police are on the roads anyway, so they have the ability to monitor as needed.

Chuck Cline of 22 Reading Road suggested that the Committee ensure the flagpole does not exceed 35 feet in height.

Seth Buchanan of 160 Lower Creek Road and President f the DTAA offered that he has a map in regards to the proposed location of the flagpole at Dilts Park. Mr. Buchanan offered that flying the American Flag will show pride in our nation, the flagpole is already existing, the cost will be small and if there are any problems the DTAA will foot the bill.

Jessica Roethel of 14 Sandbrook Headquarters Road expressed concern about possible added expense in raising and lowering of the flag.

Seeing no other members of the public who wished to speak, Mayor Waltman closed the floor to public comment.

Township Attorney Tauriello opined that it is reckless and irresponsible to continue to conduct hybrid meetings and his legal advice is to conduct all meetings in person. People have come to public meetings for hundreds of years and unless and until Trenton changes the law we will remain this way. If there are any technical difficulties with the virtual meeting equipment or software, the meeting must be cancelled which just happened to the Planning Board meeting last week.

Mayor Waltman stated that the Committee has a bill list to approve at each meeting and would not want that to be held up because we couldn't have a scheduled meeting.

Mayor Waltman stated that his major concerns are contained in the first two specific lines which are clearly unconstitutional. A person is required to obtain express permission from the owner of a private property owner and not being allowed to carry firearms in a vehicle.

Committeeman Bower agreed with Mayor Waltman and also added that he has difficulty understanding how a hunter could hunt if he is unable to carry his firearm(s) in his vehicle.

Committeewoman Lockwood was in disagreement with both Mayor Waltman and Committeeman Bower, stating that she does not want anyone on her property with a gun.

A spirited debate ensued between Mayor Waltman and Committeewoman Lockwood. Committeewoman Lockwood did not feel as though there is a need for the committee take a position on this bill.

Attorney Tauriello intervened not to weigh in on the debate, but to clarify a point, that it's not the way that you read it about your private property, everything is private property if you don't own it. It's saying that you have a constitutional right to carry but you can't carry anywhere.

Committeeman Herman offered that at first he did not have an issue with the proposed bill. He has a problem that there is nothing about machine guns and assault weapons, this bill is not going to stop the bad guys. We look at Trenton and think this is going to affect our residents in a negative way. We should let them know where we stand.

Mayor Waltman communicated that we are letting the Senate Members know that we don't appreciate them restricting these rights on our residents. He noted that West Amwell passed a resolution similar to this last month and hopefully more municipalities in the state will let Trenton know that many rural communities will not be happy with this.

Mayor Waltman opened this resolution for public comment.

Resident Ravinna Taylor offered that this is a loaded issue with many strong feelings on both sides. She noted that the bill has only been introduced and there is time for it to be amended along the way. Ms. Taylor wondered why is her Township Committee trying to meddle in state legislature.

Deputy Mayor Herman's stated that we get involved because these things trickle down to our town and when things negatively impact our residents it is our job to get involved. I did support the Post Office, and a number of years ago we took a position on the pipeline. Our state legislature is meddling with the Federal Government.

There were no other public comments on Resolution # 2022-131.

A. Discussion on flagpole for Dilts Park

Deputy Mayor Herman reported that he received an email from the DTAA requesting to put up a flag pole at Dilts Park. It will have an American Flag and a DTAA Flag which will require 24/7 lighting. Since electric will be needed, the DTAA obtained a cost estimate from an electrician in the amount of \$6,000 which they are willing to split with the Township.

Discussion ensued regarding lighting of the flag pole. More information will be obtained and it will be discussed at the next meeting.

Deputy Mayor Herman added for the record that our previous Township Clerk retired after thirty-five years and the next Clerk after her relocated due to a family matter because her husband got a job out of state, and we had another Clerk that was here for a couple of years. He noted that he does not think there is an issue with the retention of Clerks in Delaware Township.

Seeing no other members of the public come forward, Mayor Waltman closed the floor to public comment.

B. Discussion on 2023 Committee Schedule

CFO McDaniel reported the following meeting date changes:

FINAL COMMENTS OF THE TOWNSHIP COMMITTEE

All of the Committee Members congratulated Committeeman Vocke on his re-elected.

Committeeman Bower stated that we have five (5) really good and pleasant candidates for the Clerk position. Deputy Mayor Herman communicated that due to the shared service we can have more competent person because we can pay more. The Clerk will spend at least 90% of the time in our office and about 10% in the Stockton office. In addition, having the Part-Time Deputy Clerk and a Full-Time Clerk in the building will provide a lot of helping hands.

Deputy Mayor Herman communicated that he was contacted by an Eagle Scout Candidate who would like to restore the bulletin board at Dilts Park which is in dire need of repair. He would also like to provide some landscaping around the sign. Once he has finalized his plans he will come to a committee meeting.
