### **DPW PROJECTS DISCUSSION**

Mayor Herman opened the discussion of the DPW projects for the remainder of 2023 - Raven Rock Road, Mason Farm Road and the Municipal parking lot.

Amanda Khan, Director of Public Works, provided an update regarding the materials received for the Raven Rock Road project. Jay Trstensky, Roads Supervisor, provided additional information stating that the original understanding of the project was that plastic piping would be used, cement piping is more labor intensive. Additionally, they are down one employee and there are still materials (inlets) that have not been received from the vendor. Mayor Herman asked if it is still possible to complete the project before the date when asphalt is no longer available (11/1 or 11/15 due to colder temperatures). Ms. Khan provided further background information regarding the materials procurement process and delays related to that process.

Mayor Herman acknowledged these challenges, but asked how do we proceed? He inquired as to the local availability of materials. He furthered that if the project can't be completed by November, then we may have to close the road, which would be a detriment to taxpayers. He asked if we could hire temporary help. Mr. Trstensky indicated that he would investigate local availability of materials and explore hiring help.

Mr. Herman stated that the Township Committee should have been made aware of any issues earlier, because as of August, it was communicated that this project was in the "scheduling" phase. Ms. Khan indicated that projects of this type take away from the day-to-day maintenance work done by DPW. She also indicated that there were other DPW responsibilities that are time consuming, both planned (tree watering) and unplanned (clearing trees from the numerous storms). She also suggested that a project of this magnitude, as a result of an event like Hurricane Ida, should have been bid out, not accepted by the DPW.

Mr. Trstenky indicated that his next step would be to explore the availability of the missing materials, and to request quotes from excavating companies. If those components can be secured, the project could be completed in about 2 weeks.

Mr. Waltman asked that moving forward, DPW should let the TC know about issues earlier to arrange for help or go out to bid if needed.

Mayor Herman asked for an explanation of the Mason Farm Rd job. Mr. Trstensky explained that it is a drainage issue from a pond on private property that causes freezing conditions in the road. Mr. Herman asked if that issue and the Municipal parking lot issues can be handled by salting until the projects can be completed. Mr. Trstenky indicated that they can.

Mr. Bower asked for clarity on the DPW coordination once plans are received. How does the project get planned out and communicated internally. Ms. Khan replied that someone is assigned to start the procurement process. Ms. Khan provided some insight and agreed that better planning needs to be done. Ms. Khan also reiterated that there were other tasks that took away time from the 3 planned projects. Mr. Waltman asked that DPW alert the Township Committee earlier if there are things that are taking time away from big projects.

Mayor Herman stated that next steps are 1) contact excavating companies for quotes for help and equipment and 2) get the needed inlets locally. Mayor Herman asked that DPW work with Ms. McDaniel on ordering the correct needed materials. Additionally, Mr. Trstenky needs to explore the possibility of borrowing an asphalt machine for paving. Mr. Waltman asked if gravel could be used temporarily if a paver is not available. Mr. Trstenky indicated that it could and they would just clear it away before paving after the winter.

#### **PUBLIC COMMENTS**

Mayor Herman opened up the meeting to public comment.

Robert Sussna, resident, asked about the specific location of the work to be done on Raven Rock Road. Mr. Trstensky described the work zone and said it would not affect the area in front of his house. He also clarified that the pipe work will be on one side. Mr. Sussna indicated that he would like to look at the blueprint. Ms. Khan said she would make them available for him to view.

Deborah Sussna, resident, wanted to confirm that the project has been elevated to emergency status. Mr. & Mrs. Sussna also noted that they were representing other residents could not attend as they were out of town.

Ravenna Taylor, resident, asked if the project is similar to Lambert. That project was bid out, so the attendees could not speak to the details, but would find out.

Mr. Sussna thanked the Township Committee for their concern and attention.
