APPROVAL OF TOWNSHIP COMMITTEE MEETING MINUTES

A motion by Herman, seconded by Lockwood, to approve the Committee's 4/5/2021 Special Meeting and 4/12/2021 Regular minutes was approved by voice vote.

TOWNSHIP COMMITTEE LIAISON REPORTS

Deputy Mayor Vocke stated that a truck struck a pole on County Route 523 and knocked out the power and took down cable lines in the area a few days ago. He noted the subject was located and charged.

Committeewoman Lockwood noted that the Open Space Committee had a recommendation to fulfill the vacant position of Open Space Coordinator, but was unsure as to why it was not on the agenda. She stated that the chair of the Open Space Committee would like the position filled as soon as possible and that the committee is also looking for an At-Large member due to a vacant spot created by a resignation.

Committeewoman Lockwood stated that the Pipeline was being heard in the Supreme Court.

OPEN TO THE PUBLIC

Deputy Mayor Vocke opened the floor to public comment for any items listed on the agenda.

Jess Stahl of 38 Dunkard Church Road inquired about the Township Committees stance on the Cannabis ordinance. Ms. Stahl asked why the Township was opting out and felt that the Township would be missing out on revenue.

Chuck Cline, 22 Reading Road, stated that the Township could opt in at any time with the new ordinance that is being introduced. Mr. Cline also noted that the tax could not exceed 2% for cultivation and 1% for wholesale.

Ms. Stahl stated that East Amwell is looking into microbusiness options and looking into laws and taxes. She stated they formed a Marijuana Sub-Committee and have done research.

Committeewoman Lockwood stated that the proposed cannabis ordinance is well drafted and the Township does not have enough information to say for sure if this is something they want but that the current proposed ordinance allows the township to opt in at any time. Committeewoman

Lockwood noted that for now, the Township would like to wait and see as well as being interested in how the local farmers feel.

Deputy Mayor Vocke stated the Township may be more acceptable of growing versus selling in the future. Committeewoman Lockwood noted that this does not mean that the Township is currently pro or con, but would rather wait and see and have the options open.

Township Attorney Tauriello stated that from a legal standpoint, action has to be taken now or the Township will not be able to act for 5 years if they choose to do nothing. He noted that this proposed ordinance allows the Township to always be in control with everything as time is of the essence.

Ms. Stahl then acknowledged that the Township was airing on the side of caution. She then inquired why there was a \$200k jump in the budget for the police line from 2017 to now.

CFO McDaniel stated the jump was due to salary increases and the hiring of new officers during those years. Committeewoman Lockwood added that they have salary increase steps in their contracts.

Ms. Stahl then inquired how many officers were currently on the police force. Committeeman Herman stated there are currently 5 police officers plus the Chief. CFO McDaniel also noted that in 2017 the Township had a grant to hire officers which covered their salaries for the first year.

Hearing no members of the public speak up, Deputy Mayor Vocke closed the floor to public comment.

INTRODUCTION/PUBLIC HEARING ON ORDINANCES

Public Hearing on Ordinance No. 2021-04

Deputy Mayor Vocke read Ordinance No. 2021-04 by title.

Delaware Township

Ordinance No. 2021 – 04 A CAPITAL ORDINANCE OF THE TOWNSHIP OF DELAWARE, COUNTY OF HUNTERDON, AND STATE OF NEW JERSEY TO AUTHORIZE AN EXPENDITURE AND APPROPRIATION FROM CAPITALIMPROVEMENT FUND IN THE AMOUNT OF \$35,000.00 FOR THE RENOVATIONS TO TOWN HALL

BE IT ORDAINED by the Township Committee of the Township of Delaware, County of Hunterdon, and State of New Jersey as follows:

Section 1. Delaware Township has a need to renovate the existing Township Building to include windows, counters and other alternations to protect the public and employees from the public health hazard created by Coronavirus disease 2019 ("COVID-19").

Section 2. Delaware Township hereby authorizes an appropriation and expenditure for the renovation of the Township Building in an amount not to exceed \$35,000.00; and,

Section 3. Total amount to be expended from Capital Improvement Fund to make improvements to the Municipal Building shall not exceed \$35,000.00.

Section 4. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.

PLEASE TAKE NOTICE that the above Ordinance was approved on first reading at the regular meeting of the Delaware Township Committee held April 12, 2021. It will be considered on second reading for final adoption at a regular meeting to be held May 10, 2021, beginning 7:30 P.M. at Township Hall, Sergeantsville, New Jersey. At that time an opportunity will be given for all interested citizens to be heard.

Chuck Cline, 9 Upper Creek Road, inquired if the \$35,000 included a system for the internet as he feels there are a lot of issues. Committeewoman Lockwood stated that this Capital Ordinance is for windows for the offices, COVID protocols, and renovations. She stated that the technical aspect is considered "personnel" and is not included.

A motion by Herman, seconded by Lockwood to close Ordinance #2021-04 for public hearing was unanimously approved by voice vote.

Deputy Mayor Vocke read Ordinance No. 2021-05 by title.

Delaware Township Ordinance No. 2021 – 05 An Ordinance to Amend Section 230-12 of the Delaware Township Municipal Code Prohibiting the Operation of Any Class of Cannabis Businesses Within Its Geographical Boundaries

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and

establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchases items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer.

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (*i.e.*, by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Delaware has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township of Delaware in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of Delaware Township's residents and members of the public who visit, travel, or conduct business in Delaware Township, to amend Delaware Township's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of Delaware Township; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Delaware in Hunterdon County, State of New Jersey, as follows:

- 1. Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township of Delaware, except for the delivery of cannabis items and related supplies by a delivery service.
- Section 230-12 of the Delaware Township Municipal Code is hereby amended by adding a new paragraph (Y) as follows: "<u>All classes of cannabis establishments or cannabis</u> <u>distributors or cannabis delivery services as said terms are defined in section 3 of P.L.</u> <u>2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery</u> <u>service, shall be prohibited in all zoning districts."</u>
- 3. Any article, section, paragraph, subsection, clause, or other provision of the Delaware Township Code that is inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.

- 4. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.
- 5. This ordinance shall take effect upon its passage and publication and filing with the Hunterdon County Planning Board, and as otherwise provided for by law.

Delaware Township Resolution #2021-51 Local Budget Examination

WHEREAS, NJSA 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination, and

WHEREAS, NJAC 5:30-7 was adopted by the Local Finance Board on February 11, 1997, and

WHEREAS, pursuant to NJAC 5:30-7.2 thru 7.5 the Township of Delaware has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township meets the necessary conditions to participate in the program for the 2021 budget year, so now therefore

BE IT RESOLVED, by the Governing Body of the Township of Delaware that the in accordance with NJAC 5:307.6a & b and based upon the Chief Financial Officers certification. The governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year

NEW BUSINESS/OTHER

Eagle Scout Aaron Importico of Troop 65 presented his project idea to the Township Committee. He proposed to do trail maintenance at Dilts Park, repair/replace the current broken bridge, and extend the trail on the South side. He would also like to have a bench in the area and plant a Dogwood tree for shade as well as a plaque.

Committeeman Herman noted that the trail is currently closed due to a down Ash tree that Kathy Klink and DPW were working on to remove. He also stated that Aaron Importico would be working with the Recreation Committee and Shade Tree Commission to enhance the area. Committeeman Herman also noted that Aaron Importico is not a resident of the Township, but chose this project because his troop meets there.

Committeewoman Lockwood was glad that Aaron Importico was going to work with the Shade Tree Commission and that his project would essentially protect the water quality of the stream with the trees and other plants to keep the soil in place.

Deputy Mayor Vocke stated that New Jersey State Law now requires all police officers to wear body cams at all times. He stated that this would normally cost approximately \$10,000 because the current server does not meet the standards needed. Deputy Mayor Vocke noted that the Chief of Police is currently looking into a cloud based program to keep costs down as well as a grant to update the cams for free for the first year. After the cost for the system would be \$4,500 a year.

The Environmental Commission asked for approval of Joshua Goldman to be an Advisor.

A motion by Herman, seconded by Lockwood to approve Joshua Goldman as an Advisor on the Environmental Committee was unanimously approved by voice vote.

Liza Davis of the Historical Advisory Committee advised that the responsibility of the committee was started, but never finalized and they have no clear mission for their responsibilities to the Township. She stated that when it was formed in 2010, the goal was to consolidate some functions, such as street naming. She stated they also needed to clarify the line of communication between the committees.

Committeeman Herman stated that what Ms. Davis presented was a great outline and foundation to start with. Committeeman Herman noted that from personal experience what is done by the Historical Advisory Committee is more reactive. He noted that the main objective should be the line of communication.

Committeeman Herman inquired if the Township needed to pass an Ordinance for the responsibilities. Township Attorney Tauriello stated they do not and can do a resolution annually if they choose to or not.

Committeewoman Lockwood stated it would be good to bring the committees all together to advise on historical related items and it is important to incorporate them into decision making. She noted that it should not be a commission and that she has no interest in it being at that level as the Township was not happy years ago with that.

Committeeman Herman agreed that they should not be able to speak for the township and that the relationship between the two committees is very important.

Township Attorney Tauriello presented a proposal to spark conversation on the Open Space Referendum with information he gathered from what surrounding municipalities have passed.

Committeewoman Lockwood inquired to the noted 50%. Township Attorney Tauriello stated that yes that was used as a starting point for the conversation and that that was the number on the last Hunterdon County referendum and what Clinton Township also used. He also noted that although the amount can be up to 50%, they would not be bound by that amount and can do anything from 1% to 50%, giving the flexibility to change as needed.

Committeewoman Lockwood stated that amount was too much and that there cannot be an unknown as funds need to be available to negotiate for Open Space.

Committeeman Herman stated that it was only an example to use as a guideline and no need to discuss that at the moment, but to come up with our own numbers for the Township. Committeeman Herman suggested a sub-committee be started to further discuss.

Committeewoman Lockwood stated that the Township would still need a number as it is important to know what is in the account because if something is taken out, then they may not know what they have for something else.

Committeeman Herman suggested that they look at other towns, add language that would benefit the Township, and then re-discuss.

Committeewoman Lockwood inquired on committing to cents instead of percentages. Township Auditor William Colantano stated the Township would want the option and to not be specific as far as dollar amounts. Committeewoman Lockwood stated she did not agree. Township Auditor Colantano noted that it would give the advantage of debts going away and the ability to gain funds.

Township Attorney Tauriello noted that as debts decrease, it gives extra room and allows the Township to do what it deems best for the interest of the Township. Township Auditor Colantano added that it goes beyond items such as Recreation and opens money and options that can be available that were not prior.

Deputy Mayor Vocke reiterated having a subcommittee. Committeewoman Lockwood agreed but wanted to include the Finance Committee as there is more for Open Space to accomplish that is important and does not want the Open Space Committee to get into a position where they cannot acquire items due to lack of funding.

Committeeman Herman noted for example that Dilts Park was unable to repair necessary facilities and equipment due to lack of funding and that passing this would allow much needed repairs to occur sooner rather than later, providing a safer experience without having to close areas of the park due to disarray and lack of funding to properly repair. Committeewoman Lockwood stated that the Open Space Fund saves taxes and helps to preserve the land for everyone, whereas other items may only benefit a few. Committeeman Herman also stated that maintenance was never included with Dilts Park when it was acquired by the Township. Committeewoman Lockwood stated that the Township only has that one property to upkeep and that the acquired land is not neglected and does not need upkeep. Committeeman Herman disagreed and stated there is much needed upkeep for Dilts Park facilities and land.

A motion by Herman, seconded by Lockwood to form an Open Space Referendum, Sub-Committee was unanimously approved by voice vote.

OPEN TO THE PUBLIC

Deputy Mayor Vocke opened the floor to public comment for items not on the agenda.

Marilyn Cummings of 348 Rosemont Ringoes Road stated that there was old business regarding the historic orphaned cemeteries within Delaware Township that she would like the Township to hold the deed to. Ms. Cummings noted that Bob Leif, chairman of the Hunterdon County Historical Society, has done so much to identify and map the historical cemeteries within the Township and stated that there are currently 30, with 3 orphaned. She stated that the Historical Society would be willing to obtain an attorney to prepare for adoption of the orphaned cemeteries noting that Dave Redding has saved a few others and found a way to easily transfer them to the Township. Ms. Cummings noted the only cost to the Township would be for review of legal documents of the petition to the Superior Court for the deeds.

Ms. Cummings noted the three cemeteries in question were Boysenberry, Lowercreek, and Moore and would be better off protected so no one would be able to install septic's and such in the future like what was done at Locktown.

Chuck Cline, 22 Reading Road, inquired about meets and bounds and Township Attorney Tauriello stated he was not sure how they could be acquired without meets and bounds. Ms. Cummings stated that she has the process outlined and that it has been done before. Mr. Cline noted that an attorney would have to review them as a lot are on privately owned land and landlocked. Committeeman Herman noted there were already challenges with Moore being landlocked and inquired if the others were. Ms. Cummins stated she did not know and that Mr. Leif would be able to answer that.

Committeewoman Lockwood inquired if other towns have accepted such a proposal. Ms. Cummings noted that Prall House in Stockton was obtained and that Dave Redding was able to accomplish it.

Chuck Cline stated that the Historical Advisory Committee would be better to memorialize as an ordinance because 50 years ago the commission had a lot of power and dictated what residents could and could not do to their property creating issues for them.

Bob Hornby, 10 Locktown Sergeantsville Road, wanted to thank DPW and the soccer coaches at Dilts as the fields look great. Mr. Hornby also stated that the Township is missing out on capital funding by not currently having an Open Space Coordinator.

Kathy Klink, 155 Ferry Road, stated that she heard that a recommendation had been made to fulfill the Open Space Coordinator position and that there is a concern for the Township currently having that vacant.

Hearing no members of the public speak up, Deputy Mayor Vocke closed the floor to public comment.

FINAL COMMENTS OF THE TOWNSHIP COMMITTEE

Committeewoman Lockwood noted that the next newsletter was almost complete and would be mailed soon.

Committeewoman Lockwood also noted that the Green Team at the school is going to have their first virtual meeting. She stated their goal is to save the environment and look into greener energy.

Delaware Township Ordinance No. 2021 – 05 An Ordinance to Amend Section 230-12 of the Delaware Township Municipal Code Prohibiting the Operation of Any Class of Cannabis Businesses Within Its Geographical Boundaries

WHEREAS, in 2020 New Jersey voters approved Public Question No. 1, which amended the New Jersey Constitution to allow for the legalization of a controlled form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses, including:

- Class 1 Cannabis Cultivator license, for facilities involved in growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities involved in the manufacturing, preparation, and packaging of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved in obtaining and selling cannabis items for later resale by other licensees;
- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from on licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchases items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer.

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as "a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer"), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (*i.e.*, by August 22, 2021); and

WHEREAS, pursuant to section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones, and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Delaware has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township of Delaware in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of Delaware Township's residents and members of the public who visit, travel, or conduct business in Delaware Township, to amend Delaware Township's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of Delaware Township; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act; the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality; and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Delaware in Hunterdon County, State of New Jersey, as follows:

- 1. Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (P.L. 2021, c. 16), all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township of Delaware, except for the delivery of cannabis items and related supplies by a delivery service.
- 2. Section 230-12 of the Delaware Towmship Municipal Code is hereby amended by adding a new paragraph (Y) as follows: "<u>All classes of cannabis establishments or cannabis distributors or cannabis delivery services as said terms are defined in section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service, shall be prohibited in all zoning districts."</u>
- 3. Any article, section, paragraph, subsection, clause, or other provision of the Delaware Township Code that is inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency.
- 4. If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.
- 5. This ordinance shall take effect upon its passage and publication and filing with the Hunterdon County Planning Board, and as otherwise provided for by law.
