RESOLUTION #2023-101: Introduction of 2023 Budget

Diane McDaniel, CFO stated that the 2023 Budget represents a nominal increase of 2 cents. A cent is equal to approximately \$81,175. The increase is due to rising costs in goods and services.

Committeeman Waltman commented that this year 's budget was a challenge, the increase in State health benefits alone was equal to the 2 cent increase.

A motion by Waltman, seconded by Lockwood to approve the budget as it stands for adoption at the May 8, 2023 Township Committee meeting at which time a public hearing will be held. Resolution 2023-101 Introduction of the 2023 Budget was approved by roll call vote.
