The Board discussed raising its rates at the Reorganization meeting in February with the new rates effective January 01, 2024. They decided the new unit rate would be \$390 (current unit rate is \$360) It was pointed out that the DTMUA has not raised rates in 5 years. MR. RUSSO MOVED TO VOTE TO RAISE RATES EFFECTIVE NEXT YEAR TO \$390 PER UNIT AT THE REORGANIZATION MEETING IN FEBRUARY AND TO SEND A LETTER OF NOTIFICATION TO OUR CUSTOMERS. Jens Reidel, Engineer, and Chairman Floyd discussed with the Board major upgrades to the sewer plant. They felt that a larger inflow tank would be more efficient and labor saving. It would be required to locate it outside the gates in the area of the parking lot. Mr. Reidel said he will meet with his plant operations committee and see if this is a viable solution. He will then draw up plans and obtain an estimated cost.

MR. RUSSO MOVED TO INTRODUCE OUR BUDGET EFFECTIVE FEBRUARY 01, 2024. Mr. Abbatiello seconded the motion. Roll Call vote was taken.
